

New Incentive to Christian Education (NICE) Plan

It is with great joy that we are able to introduce the NICE Plan! Families of students in grades K-8 who are new to Christian education will be offered up to a 50% reduction in their total family tuition and registration for their first year of enrolling their entire family and up to a 25% reduction in their total family tuition and registration for their second year of enrollment. **The NICE Plan gives us the opportunity to introduce the concept of Christian education to families who might not otherwise consider it because of the cost of tuition. Does this apply to your family? If you have not paid tuition for your children's K-12 education in the past, this does apply to you!** This plan allows families who have not experienced tuition costs as part of their budget to transition into the experience.

Are you eligible?

- 1) Our Finance Committee will trust parents who feel this gift is intended for them (see bolded sentence in the first paragraph)
- 2) We highly recommend the entire family of school-aged children in grades K-8 enroll at Pella Christian Grade School (PCGS).
- 3) The children's previous school(s) must be a non-CSI or non-ACSI school.
- 4) In order to be eligible for this grant, all families must have applied for a grant from the Student Tuition Organization (STO). If a family qualifies for a grant from STO, the New Introduction to Christian Education Incentive Plan grant will be reduced by the amount of the discount.
- 5) Additional tuition assistance will be available to all families on a case-by-case basis.

We realize that some of you will benefit greatly from this gift while others perhaps are not in a financial situation that really needs this kind of gift. For these reasons, we want to provide you with three options that will determine how we will "process" your portion of the gift.
